Editorial

The fourth month of this year, April 2023, has passed, and the Jewish colonizers are still practicing the clearest forms of organized terrorism against the Palestinian people and their property. The Israeli occupation's terrorist behavior is clearly escalating to dangerous levels, foreshadowing the worst to come. As long as the Palestinian people remain without international protection, and without a real deterrent to restrain the loose rein of terrorism directed and focused against them, the Palestinian people, with their children, elderly, women and youth, will remain subject to direct killing, and their property will remain subject to looting in broad daylight.

The monthly report presents a number of (classified) data and indicators that the documentation and publishing teams of the Colonization and Wall Resistance Commission were able to monitor and document in order to provide further evidence of the extent of terrorism against the Palestinian people & presence.



First: Colonial Attacks

• On Palestinian Citizens & Properties

During the period covered by the report, 2023, April the Commission monitored a total of 422 violations. These attacks affected individuals, property, lands. and natural resources, and they were concentrated in the governorates of Nablus, Jenin, and Bethlehem.



During the aforementioned period, 12 Palestinian martyrs were killed in the governorates of Jericho, Hebron, Jerusalem, Bethlehem, Salfit, Qalqilya, and Nablus¹.

These attacks took different forms, as the colonizers carried out 138 attacks, while the number of attacks on property and land reached 220, in which 3 demolitions occurred that caused the destruction of 10 facilities and sources of livelihood, and 61 cases of vandalism and destruction of property and crops belonging to Palestinians, and also it included 22 cases of confiscation of property, most of them are classified as agricultural properties, including barracks, tents and tractors.

Colonizers Attacks

During the period covered by the report, the colonizers carried out a total of 138 attacks, which took the nature of organized crime, against Palestinian citizens and their property. They were concentrated in Bethlehem with 36 attacks and Nablus with 26 attacks. Perhaps the most prominent attacks of these were represented by the shooting of the citizen Hatem Asaad Abu Najma, 39 years old, in Jerusalem, by a colonizer which led to his death. As well as the martyrdom of the Jerusalemite child, Karam al-Natsheh who died because he was run over by a

colonizer while he was riding his family's vehicle before the colonizer collided with them.

• On Land & Properties

In April 2023, the Colonization and Wall Resistance Commission's staff managed to record 220 cases of attacks on the lands and properties of Palestinian citizens. These attacks included 9 bulldozing operations of lands in the governorates of Salfit, Nablus and Tubas².



• On Crops & Trees

The CWRC monitored a total of 2220 trees that were cut down and uprooted by the colonizer' militias, **including 1210 olive trees**, **510 grapevine seedlings**, most of these operations were concentrated in Bethlehem governorate, with 1705 uprooted trees, followed by Nablus governorate with 200 trees.



Demolitions

The Israeli occupation forces carried out 3 demolitions during April 2023 that resulted in the destruction of 10 houses, commercial establishments, and sources of livelihood. This included the demolition that was carried out in Hebron where




colonizers demolished 5 commercial establishments in the "Hisbe" area in The Old City in Hebron which is a part of the Flea market called "Ar-Rabish" located near the Sanniey Mosque and opposite the Al-Aqtab Mosque.³

Notifications (Demolition, Construction Halt) in the West Bank

During April, the Israeli occupation authorities issued 117 notices to demolish, halt construction, and evacuate Palestinian facilities. These notifications ranged from notifications to demolish, to halt construction under the pretext of non-licensing, or to



evict under the pretext of training. Most of these notifications were concentrated in the governorates of Salfit with 42 notices, and Hebron and Bethlehem with 21 notifications each.

The notifications issued by the Israeli occupation authorities in the West Bank serve as a means of besieging Palestinians in Area "C" and obstructing their development and urban expansion since the occupation controls planning in those regions and hinders the Palestinians' right to prepare and approve master plans. Such measures aim to exploit Area "C", which represents 61% of the West Bank's total area, for future colonial expansion and strategic purposes.

3: The Colonial Expansion Measures that will be activated in April

The Israeli occupation authorities announced, through the so-called "Civil Administration" the activation of 26 master plans for colonies in the West Bank. This announcement signifies that they were approved earlier, and now the implementation of these plans is being announced to carry out expansion operations. Some of these plans entail a significant expansion for the colonial project, and the data for these plans indicate that they target a total of 8614 dunums of Palestinian land for the construction of 1882 colonial units, with a clear focus on central and southern areas of the West Bank, specifically the governorates of Ramallah, Jericho, Jerusalem, and Hebron.



4: Land Control Measures

Seizure Orders

In April, the Israeli occupation authorities issued three orders to seize 73 dunums of Palestinian citizens' lands in the governorates of Ramallah and Qalqilia. The first order targeted **52.597**dunums of Qalqilia governorates' lands specifically in the villages of Sineria and Kafr Thulth. Meanwhile, the second order targeted 300m2 of the village of Azzun, east of Qalqilya, and finally the third order targeted 20 dunums Ni'lin village in Ramallah governorate, for the purpose of expanding a military site.

First: The Israeli occupation authorities issued the order No (23/12/-) to confiscate 52,597 dunums of the lands of Qalqilya, noting that all of these orders are subject to renewal.








Map of Military Order No.(23/13/ت) Azzun




Map of Military Order No. (23/12/ت) Sineria and Kafr Thulth

"The following values express the right of the Jewish people to self-determination in the Land of Israel, among then settlement, security, culture, and Aliyah, as has been recognized, among others, in the Balfour Declaration and the Declaration of Independence, and anchored in the Basic Law: Israel as the Nation-State of the Jewish People," the text reads. "The goal of the government decision is to instruct all officials and branches of the government, to give — as part of the considerations included when setting and implementing policy — meaningful consideration to Zionist values," it adds.⁶
