Foreword:

It becomes clear that the occupying state has unlawfully encroached all the red lines and has disregarded the basic war ethics, in light of what happened last October, as it was the month that witnessed the highest number of Israeli colonial attacks and violations which resulted in a huge number of martyrs. It is also considered the most dangerous month in terms of the forced displacement plans that the occupying state is trying to implement on the Palestinian Bedouin communities.

The Israeli occupying state takes advantage of the global preoccupation with the war of genocide that it is waging against our Palestinian people in Gaza to implement its bloody plans in the West Bank by displacing people, executing unarmed civilians, and imposing the apartheid system and blockade in one of the forms of collective punishment which is considered a war crime. However, the colonial militias are now hiding behind the laws of war and emergency that they imposed, in order to avoid being held accountable for committing these massacres.


The Palestinian people have been exposed, and are still being exposed, to a serious, prolonged attacks that relentlessly targets their existence, land, and property. These attacks are carried out either by the occupation forces or colonialist militias, who were granted the power and authority to perpetrate their crimes in the West Bank and Jerusalem.

First: Violations of the Israeli Occupation State & Colonizers in the Occupied Palestinian Territories during October 2023

During the reporting period, October 2023, the Colonization & Wall Resistance Commission (CWRC) monitored 2074 attacks. These attacks were carried out by the various bodies of the occupying state, including its colonial militia, against the Palestinian citizens and their properties. These attacks included martyrs, physical injuries, whether by live bullets or gas, as well as incursions, sabotage, theft, confiscation of properties, bulldozing lands, and uprooting trees.



However, these attacks were concentrated in the governorate of Jerusalem which witnessed 532 followed attacks, by Nablus Governorate (338 attacks), then Hebron Governorate (323)attacks), in addition to hundreds of attacks in Ramallah. Bethlehem.

and Jericho governorates.

During the reporting period mentioned above, these attacks resulted in the martyrdom of 130 Palestinians in the West Bank and Jerusalem. The governorates of the West Bank and Jerusalem witnessed intense attacks, about (58%) of the total of these attacks. These attacks included 265 attacks on property, 74 attacks on lands and natural resources, 1735 attacks on citizens and many other classifications.

Besides, 8,720 Palestinians in Gaza Strip, 73% of whom were children, women, and elderly people were killed as a result of the Israeli aggressive war on Gaza, in October 2023. Meanwhile, there were 20,000 injuries in addition to unknown numbers of bodies stuck beneath the rubble, and it seems that it is impossible to reach them due to the continuous Israeli airstrikes.

a-The occupying state's and colonizers' attacks on Palestinian citizens, their property, and places of worship:

Colonial Attacks on citizens:

During the reporting period, October 2023, the Colonization & Wall Resistance Commission (CWRC) documented 1735 attacks on citizens. Most of these attacks were concentrated in Jerusalem Governorate which witnessed 494 attacks, followed by Nablus Governorate which witnessed 256 attacks. Meanwhile, there were 243 attacks in Hebron Governorate in addition to hundreds of attacks were carried out in the governorates of Jericho, Bethlehem, Jenin, and Ramallah. These attacks varied between shooting, arrest campaigns, shutting down checkpoints and imposing traffic restrictions on citizens. These attacks caused the martyrdom of 9 Palestinians by Israeli colonizers.

Attacks on Lands & Natural Resources:

During October, 2023, the Colonization & Wall Resistance Commission (CWRC) has documented 74 attacks on Palestinian lands and natural resources. These attacks were concentrated in Nablus Governorate which witnessed 20 attacks, followed by Hebron Governorate (18 attacks). Meanwhile, 13 attacks were recorded in Salfit

governorate. These attacks affected hundreds of dunums of citizens' lands. The reporting period, October 2023, witnessed 2 colonial attempts to establish outposts on citizens' lands. In addition, the Israeli occupation forces as well as its colonizers carried out 37 bulldozing lands' operations. Most of these operations were recorded in Nablus Governorate which witnessed 12 operations, followed by Salfit, Ramallah, Tubas, Hebron and Qalqilia governorates¹.

Assaults on Trees:

During the reporting period, October, 2023, the Colonization & Wall Resistance Commission (CWRC) documented 32 attacks that targeted olive trees and caused the uprooting and burning of 2487 trees among which there were 1764 olive trees.

Most of these assaults were concentrated in Hebron governorate where 14 attacks were recorded and caused the uprooting and burning of 380 trees. Next, there were 6 attacks in Nablus governorate that caused the uprooting and burning of 1293 trees; and 5 attacks in Ramallah Governorate that affected 160 trees. Meanwhile, there were 4 attacks in Salfit that affected 162 trees as well as 6 attacks in Qalqilia governorate that affected 490 trees.

Attacks on the property of Palestinian citizens:

During the reporting period, October 2023, the Israeli occupation forces along with the colonial militias carried out several campaigns to confiscate, steal, and sabotage citizens' property. These properties included agricultural tractors, bulldozers, home cameras, vehicles, sheep, poultry, tents, solar-powered searchlights, beehives, and metal fences. During October 2023, the Israeli occupation carried out 265 attacks on citizen's property² that caused the confiscation, vandalism, and theft of approximately 218 Palestinian properties, including the confiscation of camera recordings, vehicles, bulldozers, agricultural tractors, trucks, the goods of vendors at Damascus Gate in Jerusalem, water pipes, sheep, solar panels, olive crop and the equipment specialized for it.



b Israeli Occupation's Procedures & Measures against Palestinian Facilities:

Demolitions:

During October 2023, the Israeli Occupation Authorities carried out 34 demolition operations, affecting 41 facilities in the West Bank, including the city of Jerusalem. Most of the demolition operations were concentrated in Jerusalem governorate, which witnessed 13 demolition operations, causing the demolition of 15 facilities.

Meanwhile, 5 demolition operations were documented in Nablus Governorate, causing the demolition of 7 facilities. In the Governorates of Hebron, Jenin and Ramallah, 4 demolition operations were perpetrated in each of them, causing the demolition of 12 facilities. The following chart shows that demolition operations were concentrated in the central and northern parts of the West Bank.



The demolitions carried out during the reporting period, October 2023, targeted the following facilities: inhabited facilities,

uninhabited facilities, under construction facilities, agricultural facilities, caravans, commercial and industrial barracks, and water wells.


Colonizers' Attacks:

According to what was monitored and documented by the Colonization and Wall Resistance Commission (CWRC) during the reporting period, the colonizers carried out 390 organized attacks. These attacks varied between the occupation army's protection of the colonists in their storming of Palestinian cities and communities, breaking into Palestinian villages, confiscating citizens' property, drawing racist slogans on the walls, and bulldozing lands, as what happened in the villages of Qaryut, Qusra, Jeet, Madma, Azzun, Yasuf, Kafr al-Dik, Imatin, Al Lebban Al Gharbi, al Tuana, Turmusa'ya and dir Nitham.

Furthermore, 163 vehicles were badly attacked, either by damaging or vandalism. Including the affected vehicles there were 93 broken and damaged vehicles, 17 were burned and 20 vehicles were punctured in addition to the racist graffiti that were drawn on these vehicles.

The most prominent of these colonial attacks was storming the holy places; among which is the squares of Al-Aqsa Mosque in the occupied city of Jerusalem. During the reporting period, October 2023, 7766 Israeli colonizers, protected by the occupation army, carried out 20 raids into Al-Aqsa Mosque Squares. Besides, 16118 colonizers carried out provocative tours under what is called "tourism to the squares of Al-Aqsa Mosque." In addition, a complete closure has been imposed on "al

Ibrahimi Mosque", since the beginning of the war on Gaza Strip, on the 7th of October. However, most of these attacks were concentrated in Hebron Governorate, as the colonists carried out 118 attacks, followed by Nablus Governorate which witnessed 114 attacks.



Martyrs shot by the colonizers:


During the reporting period, October 2023, the CWRC documented that 9 Palestinian citizens were shot dead as a result of the colonizers' violent attacks against them, 6 of them in the village of Qusra (4 on the first day of the colonizers' attack on the town, and two on the second day during the colonizers' assault on the funeral of the martyrs of the first day). The seventh was in the town of Al-Sawiya, south of Nablus, then in the village of Dura Al-Qara', while the last was in Ras Karkar, north west of Ramallah.

Examples on the most prominent colonial attacks:

On October 14, 2023: The colonizers forced Palestinian farmers out of their lands at gunpoint in the villages of Amatin, Jit, and Fara'ata, asking them not to go to their lands until after the end of the war.



On October 12, 2023: Israeli soldiers and armed colonizers abducted and tortured a

citizen and two employees in the Colonization & Wall Resistance Commission (CWRC). The attack continued for almost a full day. According to the victims testimonies, The Israeli Soldiers and colonizers bind, strip, beat, burn cigarettes, urinate on the three Palestinians in the village of Wadi Al-Siq. Furthermore, they took photos of them naked in their underwear and even tried to insert an object into the body of one of them.



On October 11, 2023, colonizers attacked the southeastern area of Qusra, firing live ammunition at homes and citizens who confronted them. As a result, 4 citizens were shot dead many others were critically injured.

Two days earlier, the colonizers sent this message to the people of the town, indicating the premeditated intention to attack.



On October 12, 2023: colonizers 'attack on the funeral of the Qusra martyrs: colonizers, under the protection of the Israeli occupation force, attacked the Qusra martyrs' funeral, and opened fire directly on the citizens. As a result, a father and son reportedly shot dead as they participated in burial of four Palestinians gunned down by the colonizers the day before.






On October 18, 2023: At approximately 9 p.m., group of colonizers attacked the homes of citizens in northern area of Madama village, south of Nablus, adjacent to Yitzhar Street. They burned a car belongs to the citizen Muhammad Sidqi Nassar and broke the windows of his house, as well as the windows of other two houses belonging to Sameh Hussein Nassar and Abdul Ghani Ziadeh.

October 13, 2023: a colonizer opened fire at a citizen from zero point, injuring him critically in the village of Al-Tuwanah, near Yatta/Hebron governorate.





On October 19, 2023: a group of colonizers attacked the citizen Abdullah Muhammad Fuqaha near Shilo colony while he was returning from Jenin to the town of Sinjil. They attacked his vehicle and punctured its wheels.

Colonial Terrorism & Forced Displacement:

This part of the report, documents the forced displacement cases caused by the measures of coercive environment that the occupying state has imposed, through its direct measures and through the terrorism of the colonialist militias, on Palestinian citizens in these areas.

when the flagrant aggression against our people in Gaza Strip was launched on the 7th of October, The Colonization & Wall Resistance Commission (CWRC) monitored the attacks and threats of armed colonizers, who took advantage of the fact that local and international media are focused squarely on Gaza and the global preoccupation with the war of genocide that their state is waging against its people, and most importantly, they exploit the emergency and war laws imposed by the occupying state, which protect criminals from accountability and punishment. During the reporting period, the Israeli measures caused the displacement of 9 Palestinian Bedouin communities consisting of 100 families, including 810 individuals, from their residential places.

Cases of Forced Displacement:

First: displacing the residents of Wadi Al-Siq Bedouin community / east of Ramallah / Ramallah Governorate.

Shortly after the Israeli occupation launched its war against the Palestinian people in Gaza on the 7th of October, the community, as well as the staff of the (CWRC), who stayed in the place for more than 45 days, received a series of colonizers' threats. In this community, 30 families, of 180 individuals, including 40 minors,

were residing. On the 10th of October, those families have been forced to flee their homes in the wake of colonizers threats.

• The residents of the community were living within an area of approximately one square km.



- In the community, there is a school built by residents including 120 students.
- Residents have lived on the community since the 1970s, and depend on raising sheep for their livelihood.
- •Since 1996, residents have received continuous demolition notices for facilities, tents, and barracks, under the pretext of their presence in a military zone, despite proof that it is located outside the area designated for Israeli military training.

The most prominent attacks the community has been subjected to in the past period:

- On August 13, 2023: colonizers raided Al-Tahaddi School in Wadi Al-Siq Bedouin community, east of Ramallah, vandalized many of its contents and destroyed its windows, contents, and property.
- On September 12, 2023: Armed colonizers attacked the solidarity tent that was established to support the people of Wadi al Siq and to meet their needs. The colonizers intimidated, threatened, and brutally inspected those who were there.
- On September 20, 2023: a group of armed colonizers attacked a European diplomatic delegation during its tour in Wadi al-Siq Bedouin community. That is,

Diplomats from ten European countries as well as the Palestinian citizens living in the community participated in this tour but they were brutally attacked by armed colonizers.

• In January 2023: colonizers erected a new agricultural outpost near "Wadi Al-Siq" community, the thing which forced 3 families to flee their homes in the wake of colonizers threats.



<u>Displacing Khirbet Zanota, Al-</u> <u>Thahriya/Hebron Governorate:</u>

• Immediately after a series of attacks and violent threats by the colonizers to kill the residents in case if they do not flee, 36 Palestinian families including 400 individuals, half of them children, were displaced from Khirbet Zanota in the southern West Bank. On October 28, 2023, the residents dismantled about 50 tents

and barracks, and evacuated the area with their livestock, which were about 4,700 sheep.

- The area of Khirbet Zanota, south of Hebron Governorate, is about 12000 dunums.
- All of "Zanota" area is classified as land "C". It is surrounded by the colonial bypass road from its western side, and surrounded by the colonial industrial zone on the eastern side, and by the Wall of Annexation & Expansion from the southern side, meanwhile, the colonies of "Meitar, Tema, and Shamaa surround it from its northern side.
- The displacement of this community gives the Israeli occupation full control over more than 20 thousand dunums of the lands surrounding it.
- There are 43 male and female students, including 10 kindergarten children, in the school of Zanota community. The school, which was previously demolished by the Israeli occupation force, was rebuilt with zinc panels and bricks, and includes 6 rooms, facilities, and a health unit.
- In 2016, the Israeli court issued a precautionary principle protecting the community's facilities from demolition,
- A set of demolition notices, which were not implemented, were issued against the municipal council building and the health clinic in the community.

The most prominent attacks the community has been exposed to in the past period:

• On October 12, the Israeli occupation force stormed al Tahaddi school No. 7, in the community, broke down its gate and assaulted a woman and her daughter. Following that, the colonizers attacked the citizens, the thing which resulted in 4 citizens sustaining bruises.

• On August 2, 2023, a colonizer burned 20 beehives belonging to the citizen Youssef Al-Sharha, owner of the "Sealed Nectar" apiaries.

The Forced Displacement of Ein Al-Rashash\ Thahr Al-Jabal\ East of

Ramallah

Fifteen families, totalling 95 people, including 21 minors, used to reside in the area. On October 9, 2023, a group of colonisers blocked the road leading to the community's residence. It is important to point out that the Israeli occupation army has blocked the road multiple times and the community



managed to open it again. The colonisers also blocked the water tank from reaching the area forcing the community to relocate 1500 sheep to the village of Duma. By October 13, 2023, all women and children had relocated to the village of Duma, and on October 16, 2023, all the men joined them in the area next to the Duman village.

The Forced Displacement of Khirbat Jib'it\ North of Ramallah

Eight families, totalling 25 people, including 10 minors, resided in the area. On October 13, 2023, the community left the area due to colonisers' threats. They left most of their possessions behind, fearing to



retrieve them because of the ongoing threats and because the colonisers blocked the road leading to the area.

The most prominent violations against the community during the recent period are as follows.

- On September 9, 2023, eight colonisers, riding a Jeeb and a small tractor, broke into the seasonal cattle ranch owned by Fadel Abu Alia (53 years old) in Khirbat Jib'it, vandalizing some of his possessions. They also broke the covers of the tents, the toilet, a sink, and two solar panels.
- On October 8, 2023, an armed colonizer grazed his cattle on the property of the citizens of the village of Jib'it.
- On October 11, 2023, an armed colonizer levelled areas of land from the western part of Al Mughayyir/ Jib'it in favour of the colonial outpost established on the privately owned lands in the area.

Second: Colonial Expansion Measures and Land Confiscations

a. The most prominent laws issued by the Israeli Knesset on supporting the colonial project.

In this part of the report, we document the most prominent laws and bills sanctioned by the legislative bodies of the Israeli occupation state (the Knesset). Our focus will be on the titles of these laws to provide more comprehensive analyses in upcoming reports.

b- The Most Prominent Decisions of the Israeli Occupation's Cabinet

This part of the report documents the most prominent Israeli occupation government decisions during regularly held meetings of the occupation authority. It specifically monitors all decisions made by the occupation's cabinet regarding the lands of the West Bank and Jerusalem in terms of the facilities enacted in favour of colonies or any decisions that reinforce the apartheid system imposed on Palestinians. The objective is to impose a Jewish colonial dominance that isolates Palestinians and limits their rights.

During the period covered by the report, coinciding with the declaration of war against our people in the Gaza Strip, it can be noted from the approved and deposited laws by the Knesset, that they are designed to enforce a security grip under the pretext of war laws that the occupation's Knesset imposed. Some of these laws, at their core, target Palestinian detainees, as these decisions aim to tighten the noose on them and impose harsh conditions on the detainees, whether those detained prior to the war or those who were arrested after the state of emergency. An example of these laws is the order to extend the periods of administrative detention ("Iron Swords") (Temporary Instructions) (Judea and Samaria) (No. 2148), 5784- 2023, which addresses the extension of detention periods, simplifies arrest procedures, and

the execution of arrests that do not adhere to international norms. We also note the legislative authorities' use of the state of emergency to grant new powers in the violation of the privacy of Palestinian citizens by authorising security agencies to engage in espionage and infiltration operations under the pretext of security and wartime conditions. Additionally, some laws aimed at tightening control over the media and labelling them as detrimental to the security situation in the occupying state, based on emergency regulations from 1945, were discussed and approved, such as declaring JMEDIA as a terrorist organization.

c- The Announced Colonial Expansion Plans

The Israeli occupation authorities, through the occupation's so-called "Civil Administration" deposited 4 master plans for colonies in the West Bank. These plans targeted a total of 268.35 dunums of private lands with the objective of expanding colonies on them. These master plans aim to construct 551 new colonial units and approved the construction of an electromagnetic station on the lands of the Tubas Governorate.

Land Expropriation (Land Confiscation) during the reporting Period:

Land seizure orders:

During the period covered by the report, the Israeli occupation authorities confiscated a total of 5382 dunums (1 dunum equals 1000 square meters) under different designations (such as natural reserves declaration, land seizure orders, and confiscations for security measures). Nine land seizure orders that targeted 116.63 dunums were issued, in addition to two orders to adjust the boundaries of a natural reserve, resulting in the confiscation of 44761 dunums, another order to confiscate a natural forest as a reserve covering an area of 4499 dunums, and two orders to implement security measures to take control of lands covering an area of 29.714 dunums by removing their trees and crops for security reasons.

First: The Israeli occupation authorities issued a land seizure order for urgent military purposes that carried the number (MD\23\14) that orders the confiscation of a total of 21.75 dunums of privately owned lands from the Governorate of Qalqilya, particularly in the Village of Azzun. The purpose of the seizure is to construct fences and military roads that obstruct Palestinian citizens' access to their lands that overlook Nablus Street and are adjacent to the village of Azzun. The validity of this order has been set at 60 days subject to renewal.

Second: The Israeli occupation authorities issued a land seizure order for urgent military purposes that carried the number (MD\23\15) that orders the confiscation of a total of 15.85 dunums of privately owned lands from the Governorate of Qalqilya, particularly in the Village of Azzun for the purposes of building fences and military roads that prevent Palestinian citizens from reaching their lands that overlook the Nablus Street and are adjacent to the village of Azzun. The validity of this order has been set at 60 days subject to renewal.


Map of Military Order (MD\23\13)

Map of Military Order (MD\23\22)





particularly in Nu'eima for the purposes of building a military tower. The validity of this order has been set at 60 days subject to renewal.







Map of Military Order (5\23)





Orders to Adjust the Boundaries of Natural Reserves


First: On September 3, 2023, and published in mid-October, the head of the so-called "Civil Administration" announced the adjustment of the boundaries of the Ein Feshkha\ Einot Tsukim Reserve in the Jericho Governorate next to the Dead Sea, in accordance with the occupation order regarding the protection of nature (No. 363), 1969. It was 3,739 and its area became 8,360 dunums (Eight thousand eight hundred and fifty-seven dunums) after the adjustment. Consequently, the Israeli occupation state declared its control over this natural reserve to be added to the other natural reserves controlled by the Israeli occupation state.

Map of Military Order/ The Ein Feshkha Reserve




Second: On September 3, 2023, and published in mid-October, the head of the so-called "Civil Administration" announced the adjustment of the boundaries of the Qumran National Park Reserve in the Jericho Governorate next to the Dead Sea, which has an area of 409.8 dunums (four hundred and nine dunums) in accordance with the occupation's Nature "Preservation" Reserve Area Order (Military Order No. 363/1969), 1969-5730. Consequently, the Israeli occupation state declared its control over this natural reserve, adding it to the other natural reserves controlled by the occupation state.

Third: On August 30, 2023, and published in mid-October: The head of the so-called "Civil Administration" announced the seizure of the Dotan Forests in accordance with the Occupation Woods and Forests Order (No. 306), 1969-5729, and considered it a natural reserve, which has an area of 499 dunams. Thus, the Israeli occupation state has relinquished its control over this natural reserve, adding it to the other natural reserves controlled by the occupation state.

Third: Incitement and Racist Statements by the Leaders of the Israeli Occupation State

The statements made by the Israeli occupation army's leaders who nowadays display their racist opinions fully and without fear show a case

of superiority in their racist rhetoric. In this section of the report, we quickly review the most prominent statements.

Media affiliated with colonizers' militia launched an attack on the head of the Colonization and Wall Resistance Commission, Muayyad Sha'ban, while the Israeli occupation forces incited to eliminate him clearly, the "Jewish Voice" newspaper affiliated with the colonizers published a number of articles demanding his assassination, most prominent of these articles were published on 22 October 2023 where it said, "Our dear soldiers beware, the Nazi Muayyad Sha'ban is calling in this video, in a raspy voice, saying that the martyrs are 'superior to all of us', this means that he really desires to be a martyr, we should make sure to make his dream come true". A new group affiliated with the colonizers' militia appeared in the realm of incitement. This group identifies itself as the "Nazi Hunters". This group operates on several active channels on Telegram. All of these channels have the same icon, which shows the person targeted by the incitement with a target on their head in a clear indication of their murderous intent. This group also published a number of provocative materials against Minister Sha'ban and against a number of Palestinian activists. The most prominent of these instigations was made on the 22nd of October 2023, which stated, "Many of you asked us to share this video here. This is the full video showing the Nazi, Muayyad Sha'ban, showing his solidarity with the Nazis of the Nur Shams Refugee Camp in Tulkar, who killed the solider Maxim Razinkov".

On 30 October 2023: Yossi Dagan, the head of the colonisers' so-called "Shomron Regional Council" located in the north of the West Bank, shared a message on his Facebook page, where he said, "With determination and an iron fist, we will prevail for the first time in Israel: (...) for this purpose, we have purchased hundreds of standard "Ronnie" rifles through foreign donations. The Ronnie turns GLOCK pistols into "rifle-like" weapons- with line and target, enhancing accuracy, increased

shooting range, and terrain combat capability. The Friends of Samaria raised the funding from New York, Miami, Toronto, and Paris. In recent years we have invested in friendly parliaments and strengthened friendships with Jewish communities worldwide. Now they are opening their hearts and pockets and pledged millions of dollars to strengthen the security in the colonies of Samaria. At the same time, the Samaria Regional Council is completing the distribution of 300 assault rifles purchased (...). With determination and an iron fist, we will defeat the barbaric Nazis".

On 25 October 2023, the Israeli politician and former Deputy Speaker of the Knesset, Moshe Feiglin, announced in an interview on Israeli Channel 14 that Israel will soon initiate a process to kill all remaining Palestinians living in Gaza using gas, with the goal of "complete and total" extermination of Palestinian civilians living near the Israeli occupation state.

On 28 October 2023, Yosef Yisrael, the foreign anchor of the Israeli Channel 13, gave a message to the Israeli occupation's soldiers heading to Gaza on his official account on X. The post declared, "Dear fighters, act in the most destructive ways: kill, kill, kill. Gaza needs to turn the bodies of Hamas members and their associates into smelly corpses without achieving their goals. Do not take risks. Everything that moves within the boundaries of your territory, shoot at it. The main goal is to return back safely".

On 17 October 2023, the so-called "Minister of National Security" in the Israeli occupation government, Itamar Bin Gvir, posted via his official page: "The only thing that should be brought into Gaza is hundreds of tons of air force explosives, not a single gram of humanitarian aid." Commenting on the incident of the martyrdom of two young men in Silwan in the city of Jerusalem at the hands of the Israeli occupation police, Ben Gvir posted on his page on the X platform: "We

congratulate the police fighters who eliminated two residents of Silwan who launched fireworks and injured a policeman. This is a clear message to terrorists: Do not try us! Any attempt to harm and cause harm at the same time as fighting is taking place in the South will be met with a firm response and zero tolerance. Well done to the Warriors."

On 10 October 2023, the spokesperson for the Israeli occupation army (from Haaretz) declared that in their attacks "Emphasis is on damage not on accuracy".

On 9 October 2023, Israeli occupation Minister of War Yoav Gallant said via X, "I have ordered a complete siege on the Gaza Strip. There will be no electricity, no food, no fuel, everything is closed. We are fighting human animals and we are acting accordingly".

On 9 October 2023, Likud MK Tally Gotliv said via X "I urge you to do everything and use Doomsday weapons (nuclear weapons) fearlessly against our enemies".
