Foreword:

In March 2025, the levels of attacks by the Israeli occupation forces and colonizers reached alarming levels, both in terms of their frequency and the nature of their targets, which aim to undermine the Palestinian presence throughout Palestinian territories. Compared to previous months, Palestinian citizens have increasingly found themselves targets of either official occupation measures or organized violence perpetrated by colonizers groups.

Consequently, Palestinians continue to pay a heavy price regarding their personal security, lives, and property. The Israeli occupying state seems intent on using Palestinian suffering as propaganda to advance its government's agenda, and it is inciting aggressive colonizers to act violently against those who remain steadfast in their land. In this relentless struggle, Palestinians are paying an extraordinary price, both psychologically and physically, as they strive to protect their rights, property, and existence.

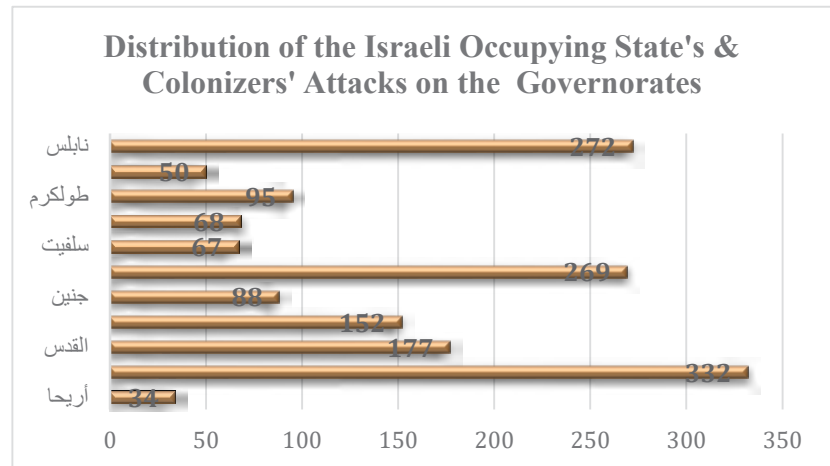

First: Violations of the Israeli Occupation State & Colonizers in the Occupied Palestinian Territories in March 2025:

During the reporting period, March 2025, the Colonization & Wall Resistance Commission (CWRC) monitored 1604 attacks. These attacks were carried out by the various bodies of the occupying state, including its colonial militia, against Palestinian citizens and

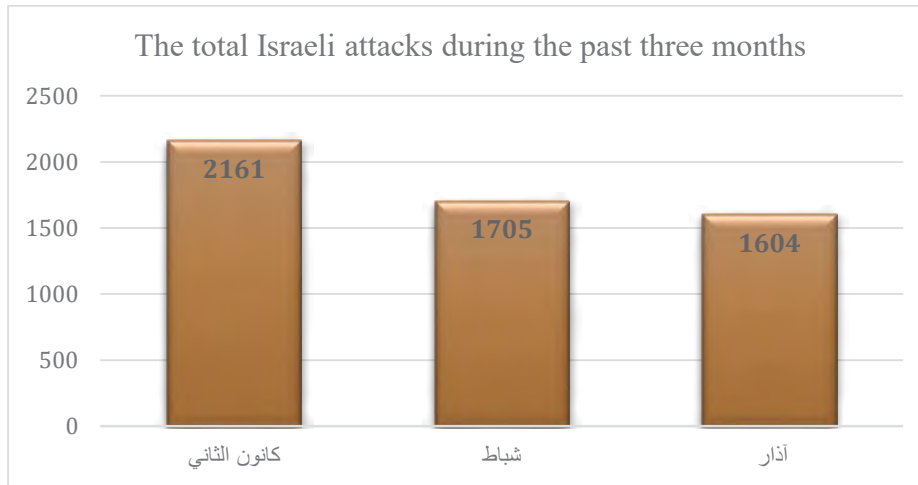
their properties. Of these, 1349 attacks were carried out by the Israeli army, while 355 attacks were perpetrated by the colonizers. These attacks included assaults and



physical injuries, caused by live ammunition, gas, or terrorism .They also involved raids, vandalism, theft, property confiscation, land bulldozing, and uprooting trees. However, the majority of these attacks occurred in the governorate of Hebron which witnessed 332 attacks. This was followed by Nablus Governorate (272 attacks). Meanwhile, 269 attacks were recorded in Ramallah governorate. These governorates experienced intensive attacks, amounting to 55% of the total attacks. The other governorates faced a similarly difficult situation. The governorates of Bethlehem and Jerusalem experienced over one hundred attacks for each.

These attacks included 373 attacks on property and holy places, 77 attacks on lands and natural resources, and 1154 attacks on citizens.

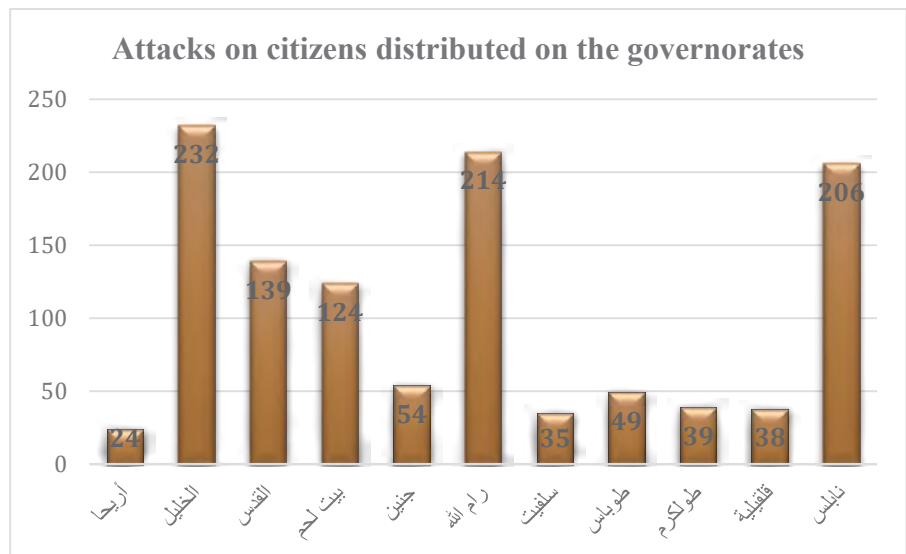
A comparison of the total Israeli violations during the past three months:



Attacks Perpetrated by Israeli Occupation State & Colonizers against Palestinian Citizens, their Properties and Holy Places.

Attacks on citizens:

During the reporting period, March 2025, the Colonization & Wall Resistance Commission (CWRC) documented 1154 attacks on citizens. Most of these attacks were



concentrated in Hebron Governorate which witnessed 232 attacks, followed by Nablus Governorate which witnessed 206 attacks. These attacks included shooting, arrest campaigns, shutting down checkpoints and imposing traffic restrictions on citizens.

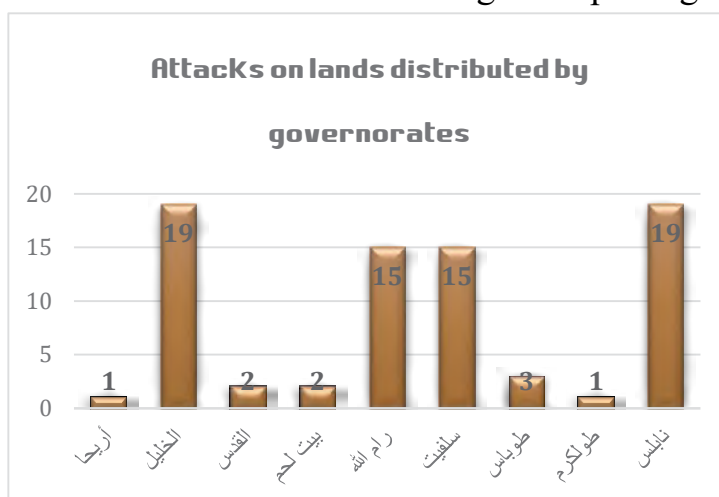

Attacks on Lands & Natural Resources:

In March 2025, the Colonization & Wall Resistance Commission (CWRC) has documented 77 attacks on the Palestinian lands and natural resources. These attacks were concentrated in the governorates of Hebron and Nablus which were subjected to witness 21 attacks for each, followed by the governorates of Ramallah and Salfit where 15 were recorded in each of them.

These attacks affected hundreds of dunums of citizens' lands. During the reporting period, March 2025, there were 6 attempts by colonizers to establish colonial outposts in the governorates of Nablus, Tubas, Ramallah, and Jericho. Additionally, the Israeli occupation authorities and colonizers carried out 25 bulldozing lands' operations.



These operations were concentrated in Salfit Governorate, where 7 bulldozing lands'

operations took place, followed by Ramallah which was subjected to 5 bulldozing lands' operations. Meanwhile, 4 bulldozing lands' operations were recorded in each of Nablus and Hebron¹.

Attacks on Trees:

During the reporting period, March 2025, the Colonization & Wall Resistance Commission (CWRC) documented 46 attacks that targeted olive trees and caused the uprooting, poisoning and burning of 1354 trees among which there were 1324 olive trees. These attacks were concentrated in the governorate of Hebron where 15 attacks were recorded, followed by the governorate of Nablus which witnessed 12 attacks. Meanwhile, there were 9 attacks in ramallah governorate and 8 attacks in Salfit governorate.

Attacks on Palestinians' Properties:

In March 2025, the CWRC documented 373 Israeli attacks on Palestinian property. During this period, the occupying army and colonial militias carried out extensive campaigns to confiscate and steal citizens' property. The targeted properties included mobile homes (caravans), agricultural tractors, vehicles, home security cameras, livestock, money, and more.

Furthermore, there were 188 incidents of property vandalism and 49 documented incidents of confiscations and thefts of properties during the reporting period. Specifically, Israeli forces confiscated 14 vehicles, 6 surveillance camera recordings, 5 bulldozers and trucks, 1 agricultural tractors, 6 cases of stealing money (gold jewelry, cash money), a case of confiscating files and papers, as well as plastic toys for children. Meanwhile, the colonizers were involved in the theft of: 112 goats, one donkey, nine camels, five horses, six instances of agricultural equipment confiscation, stealing a set of house keys .Noteworthy, these confiscations and thefts were concentrated in Hebron Governorate which witnessed 13 incidents, followed by Ramallah Governorate where 11 incidents of colonizers' confiscation were reported, and then Nablus Governorate, which recorded seven cases of confiscation and theft.

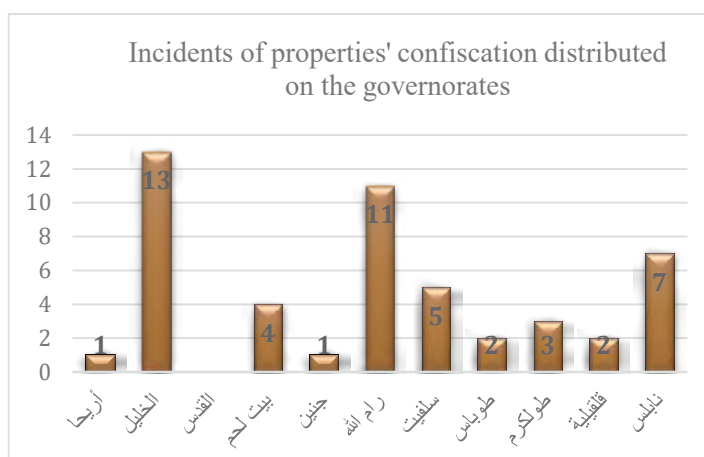

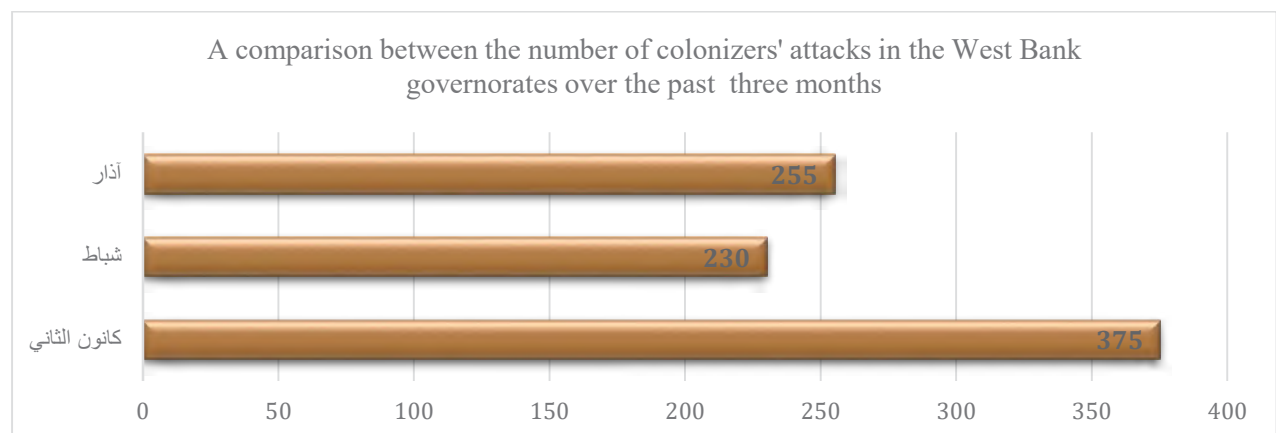
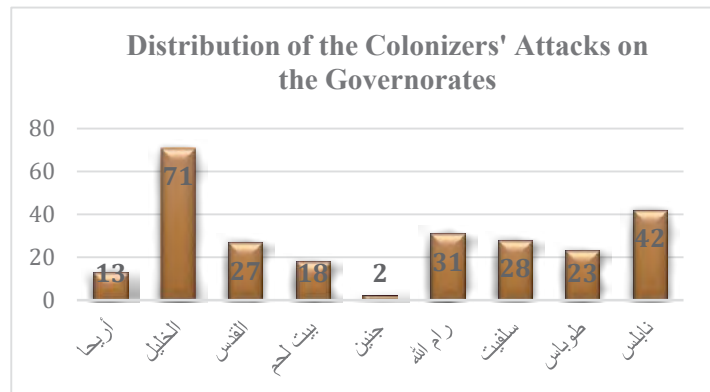

Colonizers' Attacks: According to what was monitored and documented by the Colonization and Wall Resistance Commission (CWRC) during the reporting period, March 2025, the colonizers carried out 255 organized attacks. These attacks varied between the occupation army's protection of the colonists in their storming of Palestinian cities and communities, breaking into Palestinian villages, confiscating citizens' property, drawing racist slogans on the walls, and bulldozing lands, as what happened in the villages of Qarawa Bani Hassan, Haris, Wadi Al-Matwi, Iskaka, Khallet Hassan, Khirbet Tana, Huwwara, Madama, Sinjil, Umm Safa, Deir Nizam, Umm Sidra in Masafer Yatta and other villages

The most prominent of these colonial attacks was storming the holy places; among which was the squares of Al-Aqsa Mosque in the occupied city of Jerusalem. During the reporting period, March 2025, 4784 Israeli colonizers, protected by the occupation army, carried out 28 raids into Al-Aqsa Mosque Squares. Besides, 2832 colonizers carried out provocative tours under what is called "tourism to the squares of Al-Aqsa Mosque". As for al Ibrahimi Mosque in Hebron, the Israeli attacks escalated during the holy month of Ramadan, as occupation authorities imposed restrictions on prayers at the mosque. These attacks reached its peak when these

authorities refused to allow worshippers access to the entire compound during Eid al-Fitr. The actions taken against al Ibrahimi Mosque represent a blatant and unprecedented attack, provoking the feelings of Muslims and showing a disregard for the sanctity of religious rituals.

Notably worth, most of these attacks were concentrated in Hebron Governorate which was subjected to 71 attacks, followed by Nablus Governorate where 42 attacks were recorded. Meanwhile, 31 attacks were documented in Ramallah Governorate



Examples on the Colonizers' Attacks carried out in March 2025:

On March 10, 2025, a group of colonizers established a new colonial outpost in Huwwara town, located south of Nablus. They set up tents and greenhouses on the summit of Mount Ras Zeid in Za'tara Basin. Reports indicated that the colonizers had bulldozed these lands for over a month prior to this date.



On March 11, 2025, a group of colonizers set fire to three vehicles in the village of Umm Safa, located northwest of Ramallah. In the early hours of the morning, a group of colonizers stormed in the western side of the village and attacked a garage belonging to Muhammad Yusef al-Sabti Sabah and his brother Raafat, setting it on fire, completely burning three vehicles.

On March 14, 2025, a group of colonizers, with the protection of the Israeli occupation forces, bulldozed dozens of dunams of land belonging to local citizens in “Wadi al-Matwi” area. This area connects the city of Salfit with the town of Bruqin to the west and is being targeted for a new colonial road leading to the outpost of al-Ras. About 40 ancient olive trees were uprooted and large areas



of lands, belonging to the citizens Nafez Ayoub, Riyadh and Zuhair Zuhd, were bulldozed. The Citizen “Riyad Zahd” said that colonizers uprooted about 20 ancient olive trees, between 50 and 60 years old, from the land he and his brother Zuhair own. Additionally, about 20 other olive trees owned by Citizen Nafez Ayoub were also uprooted.

On March 17, 2025, a group of colonizers established a new colonial outpost near al Auja Spring, north of Jericho. They brought obstruction materials to construct an outpost near the spring, which supplies water to the nearby Bedouin communities.

On March 19, 2025, a group of colonizers set fire to the tents of a Bedouin community in “Wadi al-Matwi area”, which connects the city of Salfit to the town of Bruqin. They attacked the community, burning their tents and damaging their

property. Earlier, they physically assaulted the residents of the tents and sprayed them with pepper spray.

In addition, the colonizers paved a new colonial road leading to the colonial outpost built on the lands of the village of Farkha, southwest of Salfit. They began laying electricity lines and rehabilitating the road leading to the new colonial outpost built on the village lands. They also bulldozed large areas of citizens' lands in “Wadi al-Matwi” area to connect the so-called “Ariel” and “al-Ras” colonies, both built on the lands of Salfit, with the new colonial outpost.

On March 21, 2025, a group of colonizers constructed an iron awning near residents' tents in Ein al-Hilweh, located in the northern Jordan Valley. This action has raised concerns about a potential increase in attacks by settlers against the local residents. The area has a history of such attacks, which include physical assaults, preventing residents from grazing their livestock, raiding tents at night, and instilling fear within the community.



March 22, 2025: a group of colonizers from the so-called “Itamar” colony, built on privately owned Palestinian land, uprooted several olive trees in the village of Rujeib, east of Nablus. The trees belong to the citizen “Shahada Jamil Rawajbeh”.

On March 11, 2025, colonizers attacked the brothers “Ghanim and Muhammad Eid Zawahra” in "Al-Maytah" area of the Jordan Valley, located east of the West Bank. The brothers narrowly escaped death after being brutally assaulted while herding sheep. They were severely beaten on the head, resulting in serious injuries. Ghanim Zawahra suffered a broken hand, along with multiple severe wounds and bruises all over their bodies.



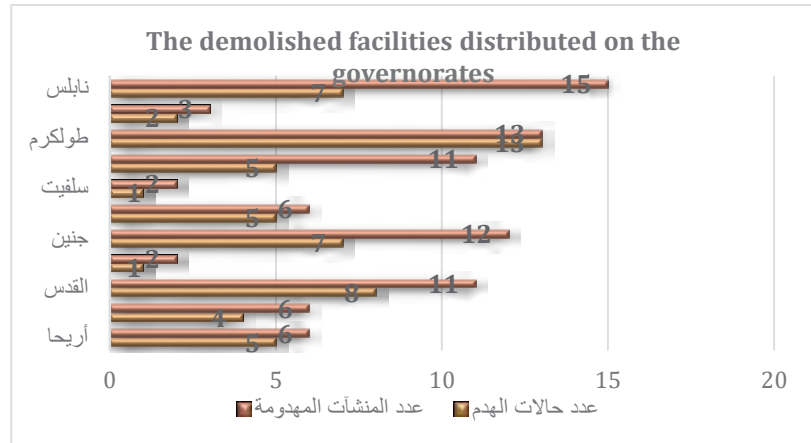
On March 14, 2025, a group of colonizers, protected by the Israeli occupation army, launched a brutal attack on “Khirbet al-Marajim”, located east of Duma, which is southeast of Nablus. They targeted citizens and their properties, and set fire to their property. As a result, three homes were burned down, belonging to Khaled Daoud, Naseem Muslim, and Nayeq Muslim. Additionally, two vehicles owned by Nayef Muslim were also destroyed due to this attack.



Second: Procedures and Practices of the Occupation Authorities against Palestinian Facilities

Demolitions: According to the violations database of the CWRC, and during the reporting period, March 2025, the Israeli occupation authorities carried out 58 demolitions that targeted 87 facilities in the West Bank, including Jerusalem.

Most of these demolitions were concentrated in Tulkarm Governorate, which witnessed 13



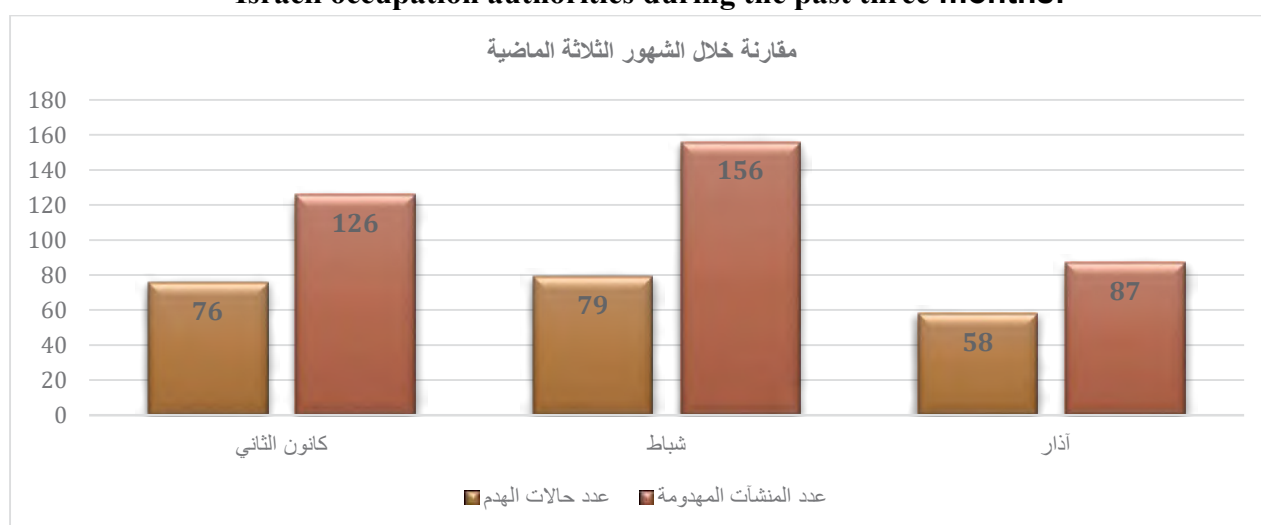
demolitions that resulted in the demolition of 13 facilities followed by Jerusalem Governorate, where 8 demolitions were monitored and resulted in the demolitions of 11 facilities. Meanwhile, 7 demolitions were recorded in Nablus governorate and caused the demolition of 15 facilities, as well as, there were 7 demolitions in Jenin governorate that resulted in the demolition of 12 facilities.

The side graph shows that demolition operations are concentrated in the northern and central areas of West Bank. Because the relationship between demolitions and demolition notifications is inherent (see the notifications section), we notice the concentration (of both demolitions and notifications) in both the northern and central areas of West Bank. These notifications are concentrated in vast areas where the Israeli occupation seeks to evacuate and forcibly depopulate in favor of the settler-colonial project. During the reporting period, these demolitions included: inhabited residences, uninhabited residences, residences under construction, agricultural facilities, mobile homes (caravans), industrial and commercial barracks, and water wells.

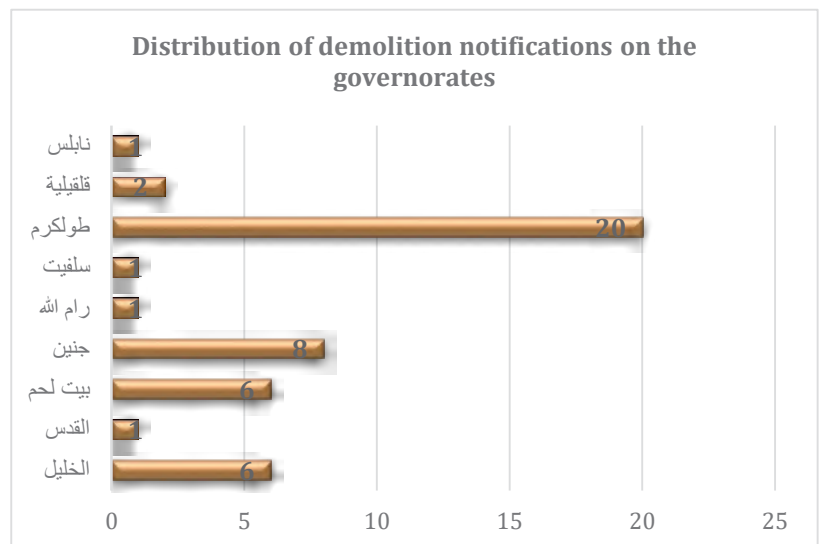
A comparison shows the number of demolitions and demolished facilities carried out by the Israeli occupation authorities during the past three months:



B. Notifications (Demolition, Construction Moratorium, and Evacuation) during the reporting period, March 2025, Israeli occupation authorities issued 46 notifications, including notifications of demolition, construction moratorium orders

due to lack of permits, and eviction notifications under the pretext of military training. The majority of these notifications were concentrated in Tulkarm Governorate which received 20 notifications, followed by Jenin Governorate which had 8 notifications. Meanwhile, the governorates of Bethlehem and Hebron received 6 notifications for each.

The demolition notifications issued by the Israeli occupation authorities in the West Bank serve as one of the means it utilizes to restrict Palestinians in Area “C” and obstruct their development and urban expansion. In light of the occupation’s control of planning in these areas, they



deny Palestinians their right to prepare master plans. Even when these master plans were submitted, they were rejected, preventing Palestinians from utilizing Area “C”, which constitutes 61% of the West Bank. This area is being kept for the expansion of colonies and as a strategic reserve for future use

Third: Land Expropriation (Land Confiscation)

In March, the occupation state issued two military seizure orders for security and military purposes, targeting 4 dunums of land in the governorates of Qalqilya and Salfit.

First order: The occupation forces seized 2.791 dunums of land from the village of Haris in the Salfit governorate under the pretext of a military and security seizure order, numbered M.D/1/25. This military order aims to establish military posts along the road adjacent to the town of Haris.

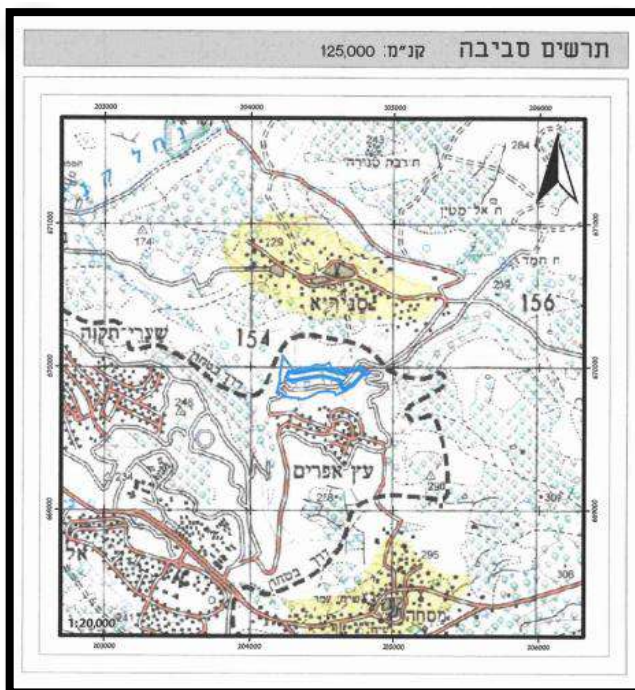


Second order: The occupation forces seized 1.203 dunums of land from the village of Azzun in the Qalqilya governorate under the pretext of a military and security seizure order, numbered T/37/25. This military order aims to establish a military tower on privately-owned land in the town.



First: Master Plans in the West Bank

In March, the planning authorities of the occupation state reviewed 38 master plans for the benefit of West Bank colonies, approving² 13 plans and depositing 15 others³. The plans targeted a total of 2163 dunums of private Palestinian citizens' land.



Analyses of the maps attached to the master plans indicate the occupation state's intention to significantly expand the "Ets Efraim" colony, built on citizens' land in Mash-ha in Salfit Governorate and Sinirya in Qalqilya Governorate. The master plan plans to establish a new colonial neighborhood by constructing 192 new colonial units on an area of 32 dunums, as approved under Master Plan No. 12\6\1\י"ש

Second: Master Plans and Bids for Colonial Units in Jerusalem

The planning authorities of the occupation state, represented by the District Committee of the Jerusalem Municipality, reviewed a total of 7 master plans aimed at colonial expansion in the colonies established in Jerusalem. They approved 3 plans and deposited 4 others. These plans targeted the construction of 237 housing units, covering a total area of 1244 dunums.

Fifth: Laws and Bills proposed or approved by the Israeli Knesset during March

In this part of the report, we review the most prominent of the laws and bills that were studied in the Occupation's Knesset. Considering the nature of these laws, their hostile and racist nature can be inferred, through which the legislative bodies in the occupation state seek to entrench a system of suppression against Palestinians or to perpetuate the racial segregation and apartheid imposed on them.

An example of this is the bills submitted by members of the far-right Knesset, which at times call for the full imposition of the occupation's sovereignty over the West Bank, and another bill that seeks to annul the Oslo Accords.

A quick glance at the set of laws currently under discussion reveals the mindset of the occupation and where it aims to go in terms of annexation, control over Palestinian land, and subjugation—openly and in plain sight of the world.

Sixth: Attitudes and Racist Statements by Prominent Characters in the Israeli Occupation State

These days, leaders of the Israeli occupation started making their racist statements unabashedly, revealing their superiority complexes and racist stances. In this section of the report, we will quickly review the most prominent statements.

- **March 2, 2025:** Israeli occupation Army Chief of Staff Dan Elyoz stated, “UNRWA is not a relief organization; it is an organization that perpetuates terrorism and should not be left untouched — it must be dismantled.”
- **March 3, 2025:** MK Zvi Sukkot from the Religious Zionism party said, “It’s time to return to Joseph’s Tomb — not like thieves in the night.”
- **March 3, 2025:** Deputy Foreign Minister Sharren Haskel tweeted on X, “The Palestinian Authority has never stopped funding terrorism — not even for a single day.”
- **March 3, 2025:** Israeli so-called “National Security Minister” Itamar Ben Gvir tweeted on X, “The government must order the bombing of the massive aid stockpiles that have accumulated in Gaza during and before the ceasefire, along with a complete halt to electricity and water.”
- **March 2, 2025:** Israeli so-called “National Security Minister” Itamar Ben Gvir posted on X: “We welcome the decision to halt humanitarian operations — if indeed implemented. The decision was finally made — better late than never. This must be the policy until the last hostage is returned. Now is the right time to open the gates of hell, cut off electricity and water as well, return to war, and

most importantly — not just to settle for half the hostages, but to return to President Trump’s ultimatum: all hostages immediately, or hell will be unleashed on Gaza.”

- **March 9, 2025:** Israeli so-called “National Security Minister” Itamar Ben Gvir tweeted on X: “Congratulations on cutting off electricity to Gaza. Israel must also bomb the massive fuel reserves that entered the Gaza Strip.”
- **March 5, 2025:** According to Ambassador Danny Danon: “The only hunger in Gaza is for our hostages.”
- **Ariel Kallner,** Likud MK: “Watch from afar the land that once was yours, while we build settlements on it.”
- **March 9, 2025:** Energy Minister Eli Cohen tweeted on X: “I have just signed an order to immediately cut off electricity to the Gaza Strip. Enough talk, it's time for action.”
- **March 11, 2025:** Minister of Environmental Protection Idit Silman, from the Likud party, stated: “The only solution is the evacuation of Gaza.”
- **March 18, 2025:** According to Naftali Bennett, far-right Israeli politician: “The United Nations has turned right into wrong, and good into evil. Good nations must condemn the United Nations.”
